



## HOME LEARNING POLICY 2018

### PURPOSE

Homework, or in this case, home learning, is defined as any task assigned by school teachers intended for students to carry out during non-school hours designed to meet specific learning goals. It is the policy of this school that some learning tasks or experiences will be set for students to complete at home. Tasks will be relevant, meaningful and based on current class work.

### POLICY REQUIREMENTS

A school's Homework or Home Learning Policy should be:

- Relevant to the needs of students;
- Developed in consultation with key school community stakeholders including teachers, parents/caregivers and students; and,
- Communicated to staff, students, parents/caregivers, particularly at the time of enrolment.

In developing their Homework Policy, schools should be aware that while the policy itself is compulsory, the setting of homework and any indicative time allocations across year levels are not.

### GUIDELINES

Community expectations about homework are variable, research regarding the value of homework is inconclusive and schools are best placed to make decisions about homework in consultation with their communities.

Malabar Public School believes:

- Reading at home to and with adults, and/or independently, is an essential part of each child's learning development;
- Homework that is set out of context or causes stress on families may have a negative influence on a child's attitude towards learning and should be avoided;
- Home learning tasks or experiences that are diverse, closely related to current class work and inclusive of a range of after-school activities already being carried out by students is more likely to be beneficial; and,
- Home learning should take into account the demands of contemporary family life and parents should have the *choice of opting out of homework* for their child if they believe it is not beneficial to the child or they feel it is having a negative impact on the child's attitude towards learning. If parents make this choice on behalf of their child, there will be no negative consequence imposed by the school.

# IMPLEMENTATION

## Kindergarten

All students in Kindergarten will be expected to complete daily home reading and prepare a weekly Speaking and Listening task.

## Year 1&2

All students in Years 1 & 2 will be expected to complete daily home reading and prepare a weekly Speaking and Listening task.

In addition, students completing home learning will be assigned further formal tasks weekly and this will include further Spelling and Mathematics tasks.

## Years 3-6

All students in Years 3-6 are expected to complete daily reading (20-30 mins). At times there will also be additional compulsory research and Speaking and Listening tasks.

In addition, students completing home learning will be assigned further formal literacy and numeracy tasks weekly as well as some optional activities.

## Responsibility of teachers includes:

- Providing home learning tasks that are consistent across the grade; are appropriate to the student's capabilities and based on current class work;
- Informing parents of intended home learning programs at the parent information evenings early in term 1 of each year;
- The provision of clear and adequate expectations;
- Correcting and/or evaluating the completed work in an encouraging environment; and,
- Providing students with the opportunity to share their work/celebrate their achievements.

## Responsibility of children (where parents opt for their child to do homework) includes:

- Taking the learning tasks home, completing them to the best of their ability and returning them to school in the agreed time; and,
- Seeking assistance from the teacher where necessary.

*Reading at home to and with adults, and/or independently, is an essential part of each child's learning development.*

## Responsibility of parents / guardians includes:

- Completing and returning a notification of an intention to opt in either partially or wholly, or opt out of home learning.

If opting in....

- Supervising and assisting children when needed;
- Making arrangements to provide adequate space and time for completion of activities;
- Encouraging children to manage time effectively, complete tasks on time and manage the balance between recreational and home learning activities; and,
- Communicating with the classroom teacher when concerns arise.

## Evaluation

Teachers will monitor the completion of tasks and indications of parental involvement. Where there is cause for concern, a parent, student and teacher conference will be organised.

Indicators of success will be:

- Greater student positivity about home learning;
- Positive parental responses; and,
- Positive impact on student attitudes towards learning.

## Participation in Home Learning

The school considers reading at home to and with adults, or independently, to be an essential part of each child's learning development. All children are expected to participate in reading at home.
